
WHEREAS, On December 13, 1967, the Executive Committee authorized the expenditure of an amount up to \$700,000 for this project; and


WHEREAS, The annual increased profits resulting from this project are estimated as \$3,150,000, and the cash return period for the project is .87 years;

NOW, THEREFORE, BE IT RESOLVED, That the action taken by the Executive Committee whereby they authorized the expenditure of an amount up to \$700,000 for the purchase of critical items which are part of a project to provide ten additional 30,000 ampere fluorochemical production cells at the Decatur Plant, be and hereby is ratified.

BE IT FURTHER RESOLVED, That the additional expenditure of an amount up to \$800,000 for the purchase and installation of ten additional 30,000 ampere fluorochemical production cells at the Decatur Plant, be and hereby is authorized, bringing total authorized expenditures on this project to \$1,500,000.










p. 21 - Qtly. Mt d. of Dir. 2/12/68




p. 22 - Qtly. Manabd. of Dir. 2/12/68




P. 23 - Qtly. Bd. of Dir. 2/12/68





p. 25 - Qtly. **Bd. of Dir. 2/12/68**






p. 27 - Qtly. Manada. of Dir. 2/12/68





