# Site-Specific Meal Advice for Tested Lakes and Rivers

The Minnesota Department of Natural Resources (DNR), the Minnesota Pollution Control Agency (MPCA), and the Minnesota Department of Health collaborate in producing the fish consumption advisory. Each year, the DNR collects fish from lakes and rivers for testing. Minnesota has around 6,000 fishable lakes. Fish from over 1,000 lakes and streams in Minnesota have been tested for contaminants.

All waters from which fish have been tested are listed in the tables below. The waters that have been tested are not necessarily more contaminated than those not tested. Waters are selected for sampling where angling is popular, where there is a known or suspected pollution source, or where fish contaminant trends are being tracked. Selections are made by:

Mercury is found in most fish tested from Minnesota lakes. PCBs are found mainly in Lake Superior and major rivers such as the Mississippi River. Perfluorochemicals (PFCs)

(http://www.health.state.mn.us/divs/eh/hazardous/topics/pfcshealth.html) have been found in some fish in Minnesota. MPCA (http://www.pca.state.mn.us/index.php/waste/waste-and-cleanup/cleanup-programs-and-topics/topics/perfluorochemicals-pfc/perfluorochemicals-pfcs.html?menuid=&redirect=1) is investigating the sources of PFCs in fish. These guidelines are based on the contaminant level measured in fillets.
